1. Please read the following information carefully and confirm your acceptance by signing the form.
2. Coaching & Bodywork by Sonja Fluss Body & Soul Therapy is not a medical therapy. I have been informed that Coaching & Bodywork by Sonja Fluss Body & Soul Therapy can complement medical therapy but does not replace it. Clients are responsible for their own physical and mental health during and after sessions. No promises of healing have been made.
3. The client informs Sonja Fluss of any physical or psychological conditions that may be relevant to Coaching & Bodywork by Sonja Fluss Body & Soul Therapy before and, if necessary, during an appointment, so that these can be considered.
4. The coach guarantees complete confidentiality regarding all confidential, personal and intimate details that the client shares during coaching and bodywork sessions.
5. The client acknowledges that the success of Sonja Fluss Body & Soul Therapy's coaching and bodywork also depends on their own commitment. The coach provides impulses and food for thought, which the client should actively commit to continuing and implementing.
6. The fee for coaching and bodywork sessions with Sonja Fluss at Body & Soul Therapy corresponds to the amount stated on the website in the energy balance.
The amount stated on the website for the energy balance. In the case of pro rata hours, the fee for the agreed service is calculated pro rata in time intervals of five minutes or part thereof; each five-minute time unit or part thereof is charged at €8.00. The quoted prices include the applicable statutory VAT, currently 19%.
7. I am aware that, in the event of an unexcused absence from an existing appointment, a cancellation fee equivalent to the full cost of the treatment will be charged. Exceptions to this agreement are cancellations made at least 24 hours before the agreed appointment, verifiable cases of force majeure, or cases where the client is not at fault. The client is obliged to provide evidence and proof for cancellations that occur less than 24 hours before the agreed appointment and are not their fault.
8. The billing for coaching and bodywork at Sonja Fluss Body & Soul Therapy is a private service for which the contractual partner is personally liable. The invoice must be paid within the specified payment period, or immediately by PayPal or in cash.
